INVITATION FOR BIDS

**THREE RIVERS SOLID WASTE AUTHORITY
LANDFILL GAS COLLECTION SYSTEM EXPANSION PROJECT**

The Three Rivers Solid Waste Authority, Inc. (OWNER), will receive sealed bids for the LANDFILL GAS COLLECTION SYSTEM EXPANSION PROJECT (BID No. 20-01-31) at 9900 Atomic Road, Jackson, South Carolina on August 17, 2020 until 12:00 p.m. local prevailing time. Bids received after this time will not be accepted. All bids shall be submitted in a sealed envelope clearly marked “Bid for Three Rivers Solid Waste Authority, Landfill Gas Collection System Expansion Proposal – Bid No. 20-01-31”.

The project consists of furnishing and installing, complete, including labor, equipment, parts, materials, and other work incidental for the expansion of the existing landfill gas collection system at the Three Rivers Solid Waste Authority Landfill. The facility is located on Atomic Road near Jackson, South Carolina. The project includes the expansion of the existing landfill gas collection system within the landfill footprint (in waste). The project includes the installation of approximately eight (8) vertical extraction gas wells, approximately 1,200 linear feet of below grade gas piping, approximately 570 linear feet of a toe drain with a liquids collection sump, upgraded forcemain system, and related work.

The LFG collection system expansion work must be substantially complete as defined in the General Conditions within twenty-eight (28) calendar days of the date fixed by the Notice to Proceed and shall achieve final completion within forty-two (42) calendar days of the date fixed by the Notice to Proceed.

A mandatory Pre-bid Conference to answer questions will be held on July 30, 2020 at 11:00 a.m. in the Three Rivers Solid Waste Authority’s Conference Room, 9900 Atomic Road, Jackson, South Carolina. Attendance is required as a precondition to bid. There will be a site tour immediately after the Pre-bid Conference. Carlson Environmental Consultants, PC and the OWNER are not responsible for the timeliness or guaranteed delivery of Bid Documents by third-party carriers. At the bidder's request and separate expense, the bidder may choose to use other means of courier services.

To qualify, all bids shall be submitted using bid forms contained in the Contract Documents. Incomplete or segregated bids will not be accepted. All bids must be accompanied by a bid security in the form of a cashier's check in an amount equal to at least ten percent (10%) of the amount of the bid by the CONTRACTOR, payable to the Three Rivers Solid Waste Authority, Inc., as guaranty that if the bid is accepted, the Bidder will execute the Contract within the time provided in the Instructions to Bidders. No bonds will be required for this project. Bids shall be valid for a period of 90 days after submission; any bid withdrawal shall be as set forth in the Instructions to Bidders.

The OWNER reserves the right to accept alternates in any order or combination, to negotiate with the Bidder it accepts in any manner or form that is in the best interest of the OWNER, or to award the Contract to a Bidder other than the low Bidder. The OWNER reserves the right to reject any bids from any Bidder currently engaged in litigation against or a contractual dispute with the OWNER.
